

## **Terms and Conditions**

### **Agreement between user and wavna.org**

Welcome to wavna.org. The wavna.org website (the "Site") is comprised of various web pages operated by Walpole Area Visiting Nurse Association ("WAVNA"). wavna.org is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms").
